Each year Arundel Lodge hosts a gala to support programs and services for the approximately 3,000 clients we serve annually. In the past, we have gathered with over 150 attendees and raised over \$120,000 annually with this event thanks to the support of our community. We are so very excited to be planning this year's event on June 28th, 2025 to raise funds and celebrate 50 incredible years of helping the community.

Arundel Lodge has a variety of behavioral health programs that assist individuals from all walks of life; seniors, adults, children, young adults, families, veterans and their families, and the deaf population. We work with both insured and uninsured clients, also providing support in gaining access to insurance programs. In addition to working with our therapists, we offer a day program, residential program, supportive living and supported employment programs, as well as a health home for both preventive care and behavioral health support. Arundel Lodge is also home to the Open Eye Art Gallery, where clients have the option to attend art classes 4 days a week and create their own masterpieces, allowing them to be working artists and sell their works for an 80% profit, with 20% returning to the program for supplies.

Arundel Lodge also operates the Behavioral Health Urgent Care Clinic on the campus of Luminis Health Anne Arundel Medical Center, making it the only facility of its kind in Anne Arundel County. The Urgent Care Clinic allows people in crisis to have direct access to clinicians who are trained to help them on the road to recovery in a relaxing, safe setting, without having the extreme wait common in most emergency rooms.
